Subj: FISCAL YEAR 2023 TACTICAL COMBAT CASUALTY CARE TRAINING SCHEDULE

Ref: (a) MARADMIN 338/21 Implementation of Tactical Combat Casualty Care
All Service Member Tier I Training

- (c) NAVMC 3500.18D Marine Corps Common Skills Volume I Training and Readiness Manual
- (d) MARADMIN 421/22 Tactical Combat Casualty Care-Combat Lifesaver Implementation
- 1. In accordance with reference (a), Headquarters Battalion (HQ BN), Training and Education Command (TECOM), will implement the Tactical Combat Casualty Care-All Service Member (TCCC-ASM) training and certification to all assigned Marines and Sailors. This is not a requirement for civilians. Certification for FMF and SE Marines is required within 12 months prior to deployment per ref (B). Marines receive their initial TCCC-ASM certification at ELT; operational commanders are responsible for pre-deployment recertification of TCCC-ASM. TCCC-ASM is a joint standardized certification being implemented within the Marine Corps to all Marines and non-medical Sailors, providing the initial medical skills necessary to ensure lifesaving treatment can be rendered in the absence of a Corpsmen and improve the survivability of those wounded or injured in combat.
- 2. Per reference (d), Headquarters Battalion (HQ BN), Training and Education Command (TECOM), will implement the Tactical Combat Casualty Care-Combat Life Saver (TCCC-CLS) training/certification and will ensure at least two marines per corpsman on the unit table of organizations are trained and certified in TCCC-CLS. Certification is every three years or within 12 months prior to deployment and yearly sustainment.
- 3. Training is accomplished via the presentation of materials via slide deck, the didactive method, and practical application and testing evaluated by appointed TCCC Trainers, skills training. Trainers will utilize the standardized and approved curriculum provided at the Defense Health Agency-sponsored deployed medicine website by the Defense Health Agency, https://www.deployedmedicine.com.
- 4. The TCCC-CLS/ASM trainer course schedule is listed below.

Subj: FISCAL YEAR 2023 TACTICAL COMBAT CASUALTY CARE TRAINING SCHEDULE

- a. Each company is resonsible for providing a minimum of two Marines to become certified trainers. Trainers will be able to conduct CLS and ASM training.
- b. Each TCCC CLS/ASM Trainer Course will have 12 allocations for the battalion. Individual company allocations, specific instructions, and requirements will be provided in a Letter of Instruction prior to each course.
- c. Instructor training involves the completion of an online course, and didactive training by the Battalion Medical Instructor Trainer. Once complete, trainers will be appointmented by the battalion commander.

- a. Each company will rotate as the lead for each TCCC-ASM training. All training will be supervised and coordinated through the HQ BN Corpsman. They will be present at all training to observe and assist the trainers, as needed. Trainers from all companies are requested to assist with each iteration as feasible.
- b. Course materials will be provided by the HQ BN Corpsman. Individual First Aid Kits (IFAK) must be requested from supply by the lead company.
